1. In case of 24-hour flexibility, the fee is €2,000 (flexible) and €4,000 (non-flexible) in currencies, the cancellation charge shall be more than the basic fare plus fare change (if relevant) for a domestic sector. Full change is already charged and not refundable.

**Note:**

- 1. Taxes/charges are applicable per person. In case of non-refundable fares there will be no refund.
- 2. In case of no-advance: Applicable Change and difference of fare if any as applicable.
- 3. **Commuting Fare:** RTD fares will apply for change/cancelation/refund/transfer.
- 4. In case of flight re-booking:
  - a) Advance arrangements can be made by the Airline. No Refund.
  - b) Passenger is liable back to the point of origin by the first available service. Full amount to be refunded.
  - c) In case of re-booking for the same carrier within the permitted flexibility period, the fare difference will be refunded.
  - d) The passenger is not liable for the standard deviation (up to 10%) unless it has been agreed. Full refund is subject to re-booking with confirmed non-refundable fares, if any.
  - e) In the case of a re-booking to a different carrier, the fare difference will be refunded.
- 5. **Transfer:** Full refund is subject to re-booking with confirmed non-refundable fares, if any.
