Note:

1. Taxes and charges are applicable per passenger. In case of "non-refundable", taxes will be refunded.
2. Rules of the carrier apply to all changes and cancellations of fares if any are applicable.
3. Cancellation fees: \$40 per person per flight for change calculation fees/transaction.
4. In case of flight disruption:
- a. alternate arrangements are made by the carrier. No refund.
- b. Passenger is taken back to the point of origin by the first available carrier. Full amount to be refunded.
5. Other arrangements for the cancelled sector is made by the passenger(s). Refund of basic fare for the cancelled sector.
6. The passenger is not liable for the change calculation fee if a change is made before departure. Full refund is given in respect to PNR along with unutilized fare within 1 year, if any.
7. No for-valuation cancellations fees applicable on return flights.
